To merchant, please read and fill out this application and return to the merchant coordinator (HL Margaret Fae) at the address noted above. Space is limited; get your app in early! **Deadline for applications is August 24th!**

- ❖ **Merchant fee does not include site fee.** Please pay your site fee once you get to site, or go through pre-reg system. **We encourage merchants to pre-reg for their site fee – it will save time when you arrive!**
- ❖ Merchant fee is due with this application. **Merchant fee is non-refundable if cancelled after August 1st.**
- ❖ Merchants shall wear appropriate SCA garb at all times except at set-up and tear-down, and create a period appearance in your merchant space.
- ❖ Merchants can arrive as early as 10:00 AM on Friday, September 2<sup>nd</sup>. All merchants must be off site no later than 5:00 PM on Monday, September 5<sup>th</sup>.
- ❖ Please provide your own manpower to set-up and tear-down your booth. The event staff will not be available to help you with this.
- ❖ Please supervise your children and pets at all time. Keep your pets on leash, and pick up after them.
- ❖ No smoking is allowed in the Marketplace or in any area that interferes with the comfort of others.
- ❖ **Water is NOT available on site.**
- ❖ **Electricity will not be available.**
- ❖ Merchants may park their vehicles with their booths as long as the fee for the entire square footage is paid, and the vehicle is covered (disguised).

NOTE: Since food merchants provide modern food using modern methods, their booths should focus on health and safety and need not focus on period appearance. Food merchants still need to wear SCA garb. Food merchants are responsible for following all regulations required by the Health Department. Expect to be inspected!
